**YOUR RIGHTS MAY BE AFFECTED.** Absent timely response, the court will approve the trustee's compensation and expenses and the pending fee application and disbursements will be made as proposed. If you do not want the court to grant the motion or the trustee to make the disbursements as proposed, then on or before **Jun 28, 2014** , you or your attorney must:
